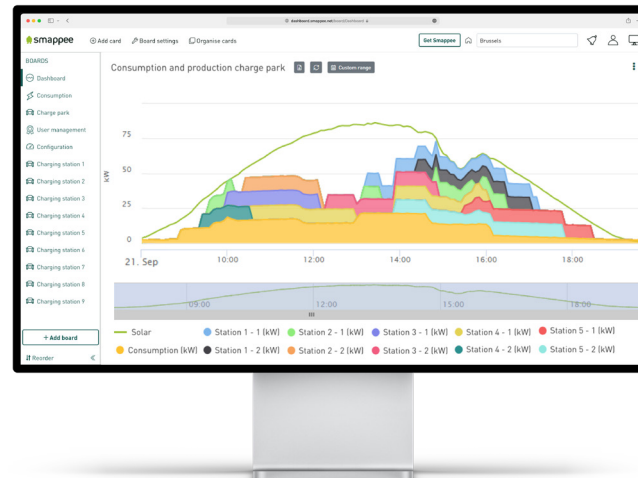
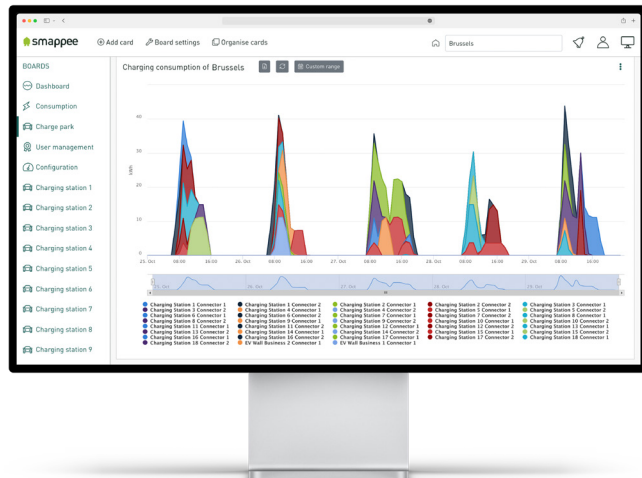

Priorities and white listing with Smappee Smart Charge cards.

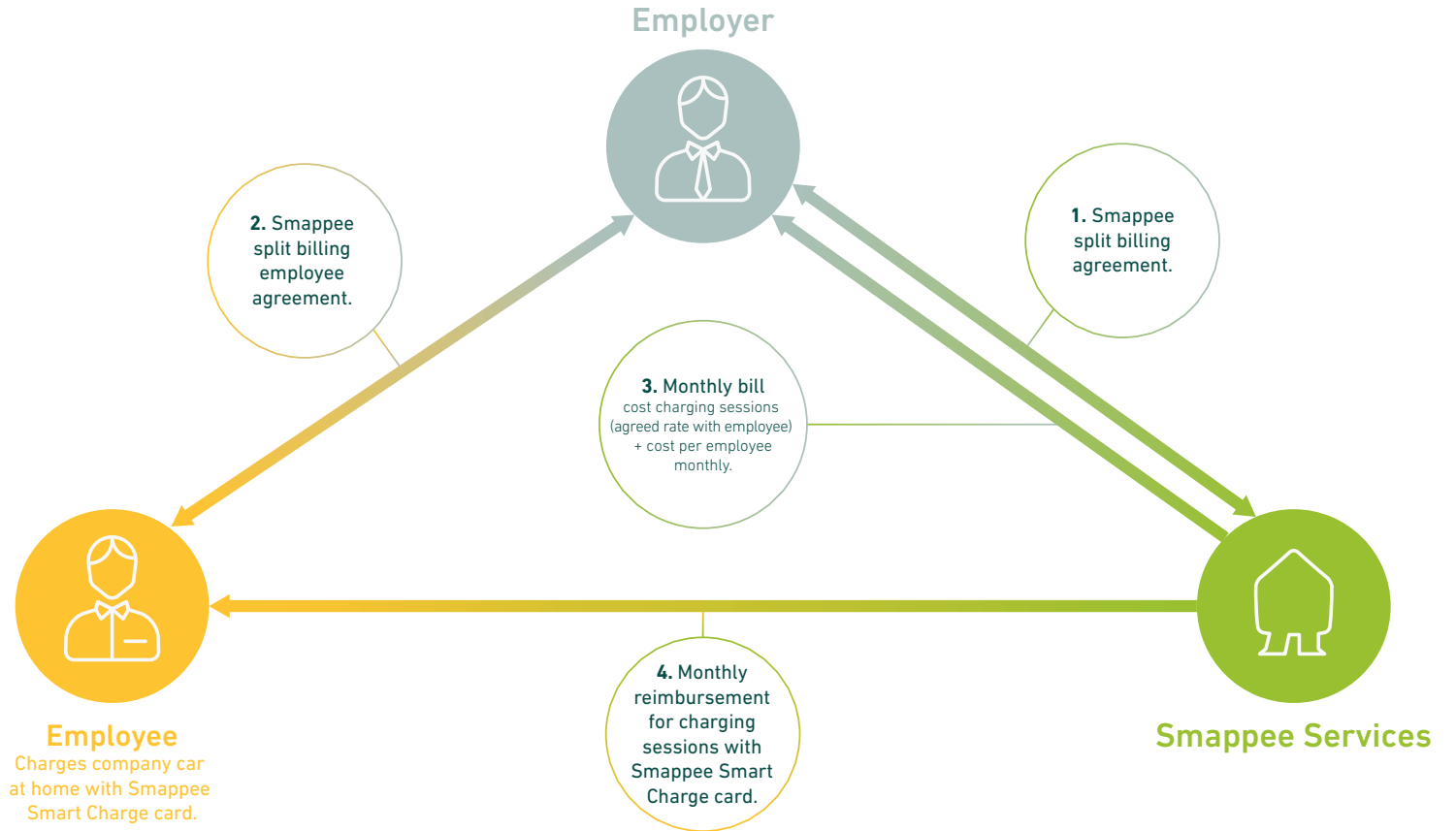

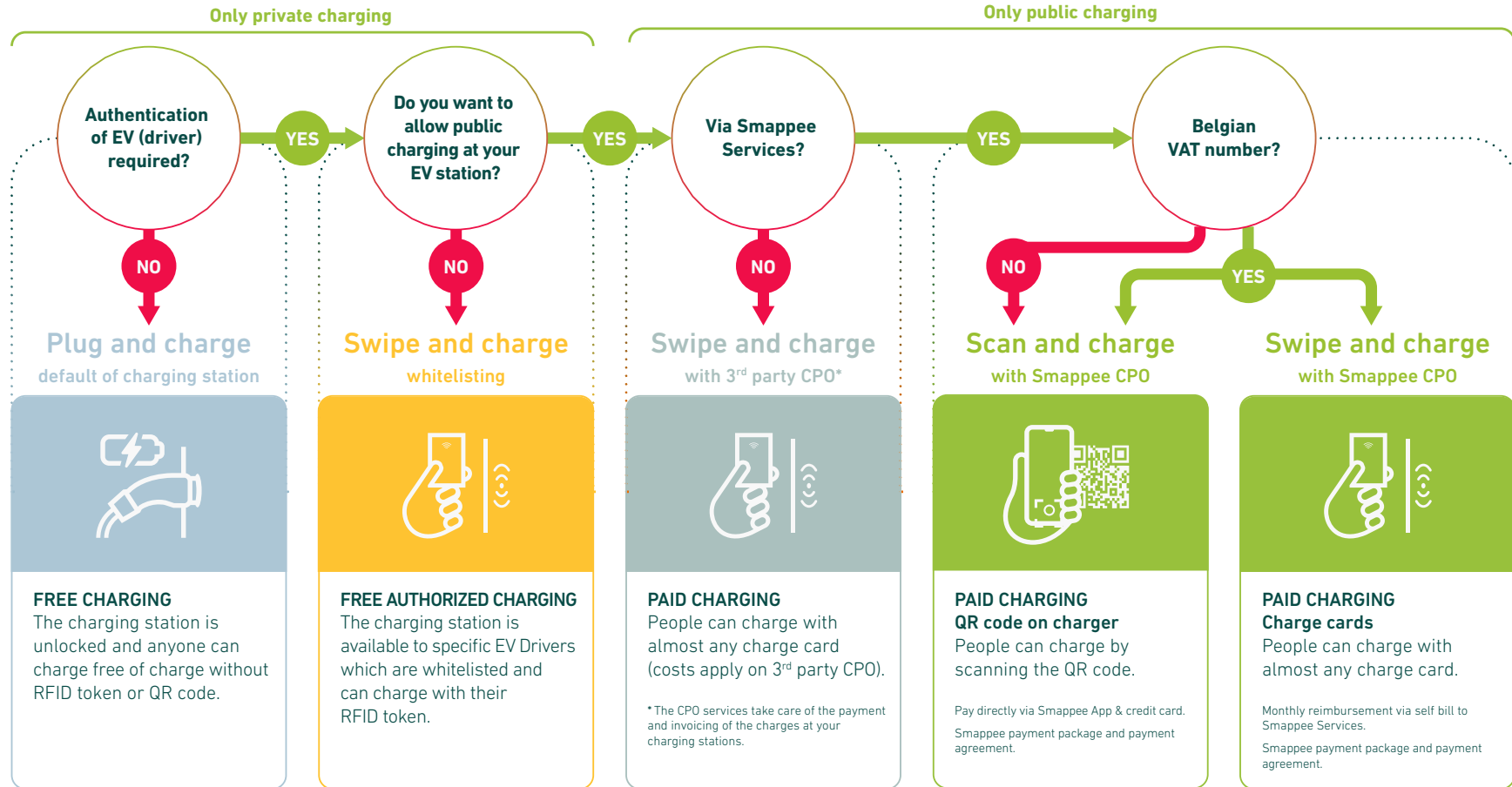
Split billing.

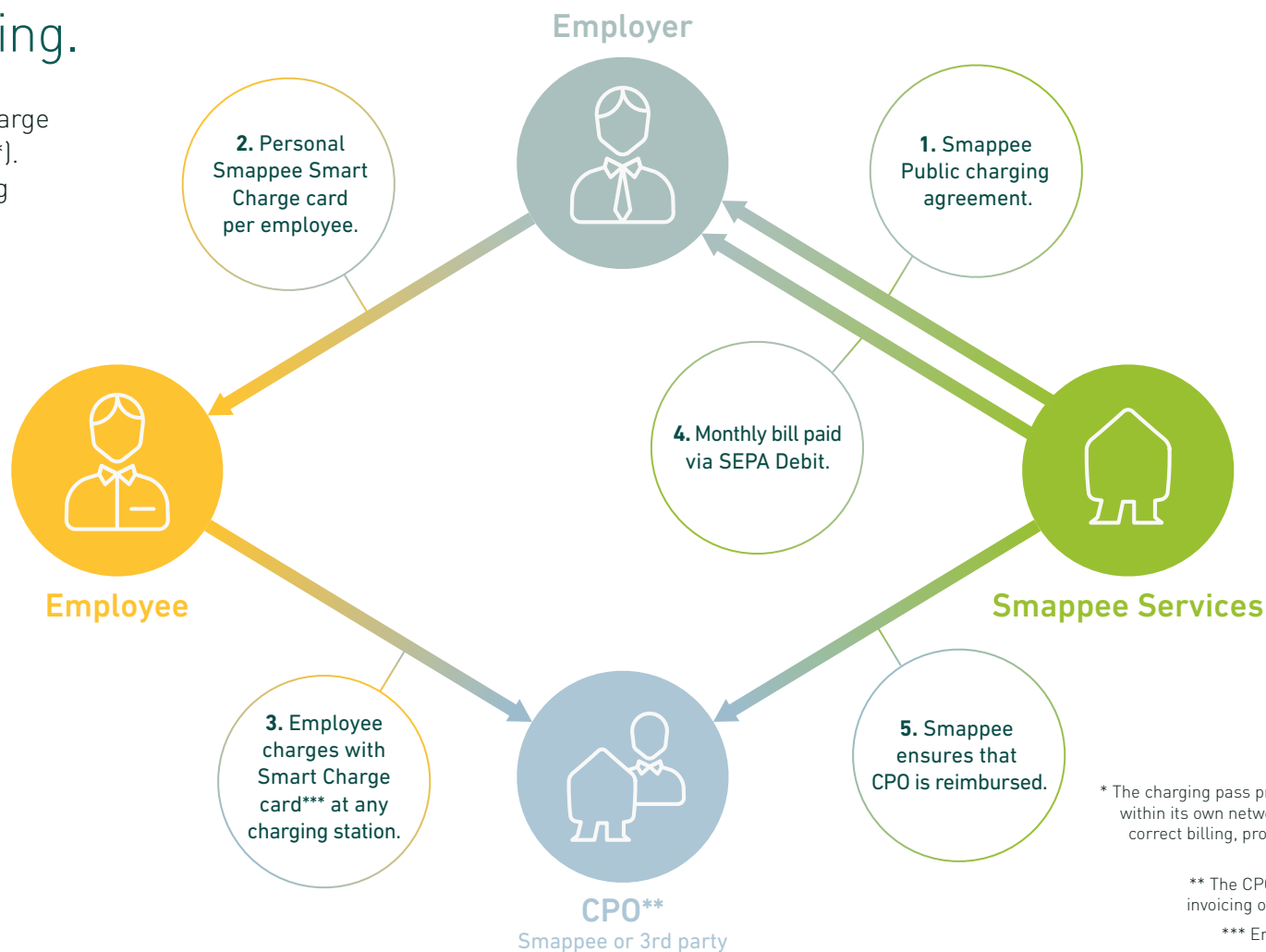


Payment options for your charging square.

*** Employee sees cost per charging session (before and after charging) in app.

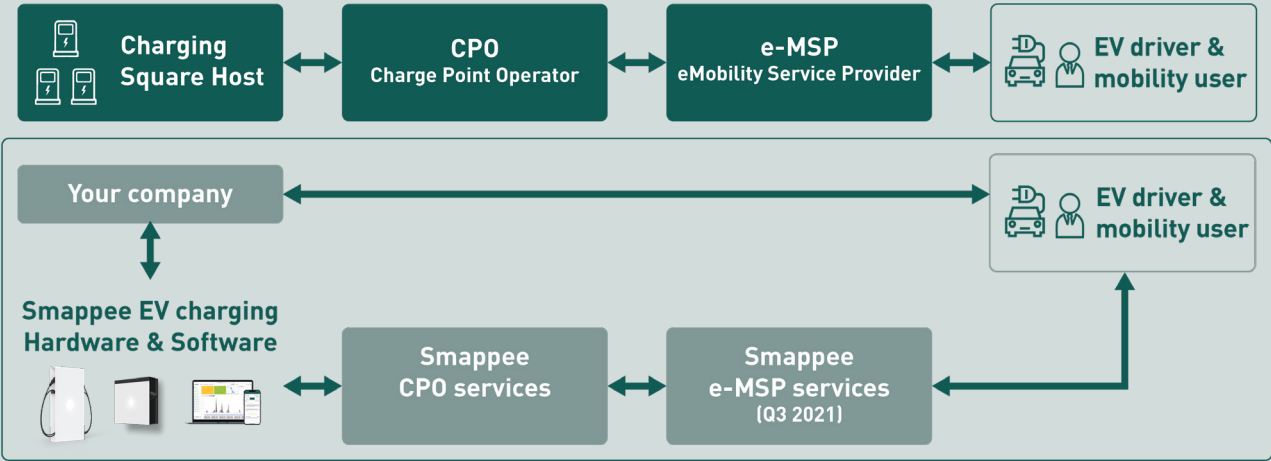

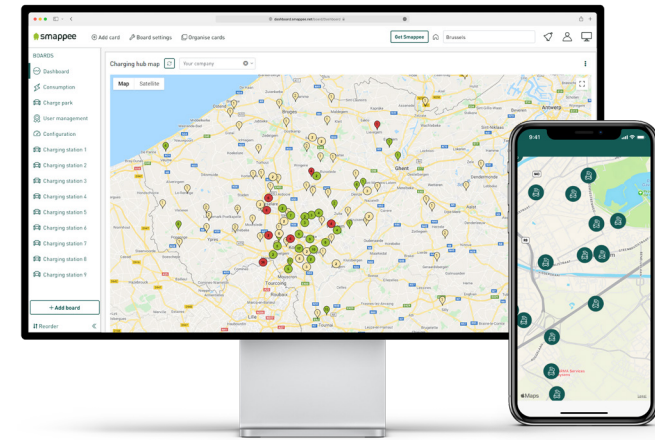
Smappee E-Mobility Service Provider Services (e-MSP).

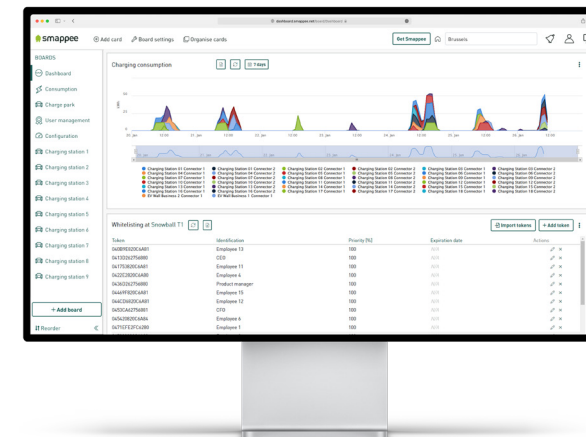
How Smappee e-MSP works:

- Activate the Smappee e-MSP service by signing the contract with Smappee Services.
- Get the Smappee Smart Charge cards and hand them to the EV drivers within your organization.
- Access third party and public chargers with your Smappee Smart Charge card and pay for your charging sessions at the tariffs and conditions announced by that provider.
- Smappee offers one of the largest charge point networks in Europe > 200.000 charge points.

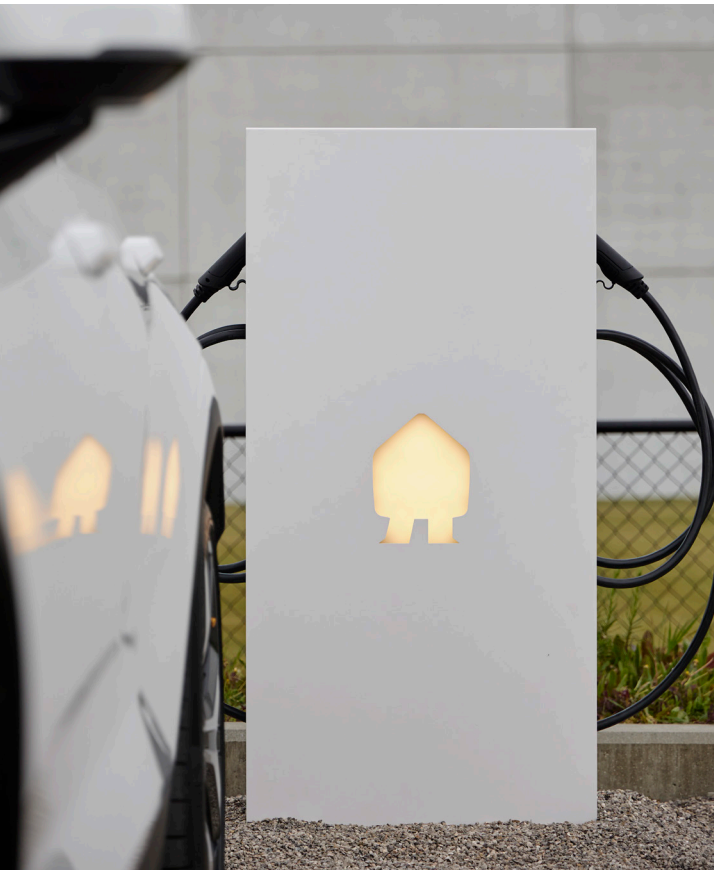

Smappee Charge Point Operator (CPO) Services.

The Smappee CPO services take care of the payment and invoicing of the charging sessions at your charging stations. EV drivers can charge using their charge cards linked to the Smappee or third-party e-MSP. Smappee will then reimburse you for the charges periodically.



How Smappee CPO Services Work:

- Multiple third party e-Mobility Service Providers (e-MSPs) linked to the platform.
- Allows drivers to use multiple charge cards from the e-MSPs at your Smappee charging stations.
- Charging square host receives payment for the charging sessions via the Smappee CPO services.
